W1DC Repeater News:

The updates to the W1DC, Billerica repeater have been almost completed. A Kenwood TKR-750 repeater and a modified Mastr II power amplifier, along with an S-COM 7330 controller and a link radio plus antenna have been installed. We are waiting for the delivery of a new repeater antenna.

The major change is the CTCSS is now 146.2Hz, which is the standard sub-audible tone on MMRA two meter systems.

Details about the equipment can be found at https://www.mmra.org/repeaters/BCA/. The system will have the same capabilities and features as other MMRA sites.

The W1DC default will be unlinked mode. If you are a MMRA member, commands are available to link different repeaters together. EchoLink and IRLP can be used by first linking to one of the two HUB repeaters.

As part of the MMRA, information is transmitted at regular intervals. On Tuesdays, a reminder about the Technical Information and Other Stuff Net will be heard at three hour intervals. All analog repeaters except for 10 meters, will be linked together, including 147.120, for the net. Net control will call the different repeaters asking for check ins. After all systems have been called, hams can make comments or talk about the topic of the week or technical information and other stuff. 20 repeaters plus affiliated systems such as the N1IMO network are connected for this net. The repeater will also be linked on the first business Monday of the month for the Eastern Massachusetts section ARES test drill and during ARES activations. There are no current plans to link 147.120 for any other regularly scheduled nets.

We want to thank the MMRA Technical Officer Bob, K1IW for system construction and controller programming, the repeater site work crew including Bob DeMattia, Mike Rioux and myself, the MMRA Board Of Directors and the members for making the upgrade happen. The 1200 Radio Club remaining members – Mike W1USN and Mike K1TWF, are thanked for the transfer and for donations for repeater components and operation. The remaining funds have been donated to the F.E.M.A.R.A. scholarship fund.

Welcome to the Twelfth BARS CW Corner By Tom Walsh, K1TW

The Icom 705

Last month I began to address the common question heard from many newer hams: "I need advice on buying my first radio." Take a look back at the April CW Corner if you missed it. This month I want to consider the truly amazing ICOM 705 as a CW QRP transceiver.

Two caveats up front however:

- these are just my opinions and you are very welcome to disagree with them;
- a QRP radio may not make the best first radio choice for a new ham.

The IC-705 has almost everything you'd expect in a high-performance home station except power!

What appeals to me most is that the IC-705 has virtually all the features of a modern transceiver in the size of a hand -held lightweight portable radio that can be easily taken to POTA, SOTA and other field activations using simple batteries.

The IC-705 is a 10-watt radio. (note: 5-watts when using the internal batteries). The IC-705 is a modern HF radio with an amazing array of features jammed packed inside it. What intrigues me is whether the ICOM 705 is a good buy at the current price of \$1349.95.



IC-705 Price today versus an FT817 back in the day

If I look back 20 years to my first full featured QRP radio, it would be a Yaesu FT-817. An FT-817 configured with a narrow CW filter was a decent performing HF general coverage QRP transceiver.

An FT-817 back then would cost close to \$800 with the added needed filters. \$800 in 2001 or so turns out to be the equivalent of about \$1369 today. Almost exactly the same cost as an IC-705 today! Since, with inflation considered, you actually get much more capability in the IC-705. In my opinion, the IC-705 wins on both performance and features for the price today.

Comparison to a present-day FT-818nd

Okay, today's FT-818nd (feature wise) is almost the same as the original FT-817 except for one major problem. The FT-818nd narrow CW filters are no longer available from dealers as accessories. For CW use, I would look to other transceivers available today with proper CW filtering unless you can locate a used FT-818nd already configured with a cw filter.

The IC-705 Feature Set

The feature set of the IC-705 is incredible and is what makes it worth considering. Here is a brief summary of key features:

- Small and lightweight (about 2.4 pounds)
- General Coverage Receiver, LW, MW, FM, Air Band, etc.
- HF/50/144/440 MHz Multimode
- Spectrum Scope and Waterfall Display
- The waterfall display is said to be the same or very similar to that on the IC-7300
- DSP Filtering
- Voice memories
- CW memories
- 10-watts on external power source
- 5-watts on internal batteries
- CAT control and Digital modes (RTTY, PSK, WSPR, WSJT, FT-8, etc.) via USB interface
- Bluetooth
- Noise Blanker
- DSP Noise Reduction
- GPS Receiver
- D-Star

That is a lot of capability in a very lightweight, very portable unit. What it lacks is likely in the eye of the beholder. One of the main things frequently mentioned is the lack of an internal antenna tuner. Icom makes a nice external ATU however as an accessory (i.e., AH-705) and so does LDG amongst others.

Not including the ATU helps keep it lighter weight. You may not need the ATU if you have resonant antennas or another ATU already. There are many additional accessories to choose from beyond an ATU such as a nice backpack, various stands and protective cases, and larger capacity batteries, etc.

Some last thoughts

ICOM has really produced something extraordinary. What is important is for each person to find the radio that best suits their

budget, interests, and preferences. Half the fun is deciding for yourself.

The features, performance, and price of an IC-705 place it in the upper range of QRP radios, along with other fine radios such as the Elecraft KX-2 and KX-3. Icom and Elecraft also have great customer support which is also a consideration when choosing any radio.

There are less expensive choices out there for portable CW QRP (e.g., Xiegu). Want to compare the IC-705 with other radios? K4SWL has some very nice You Tube videos on various POTA radios.

FCC Not Processing Amateur Radio Applications

On Wednesday, April 27, in a notice to all VECs, the FCC again asked them to refrain from submitting any amateur radio exam session or license application files while the Commission works to resolve an issue with the Universal Licensing System (ULS) application filing system.

The ULS application filing system was not functioning properly last week and then the FCC indicated the problem was resolved, as previously reported by ARRL.

However, this was not the case, as no new amateur radio call signs and licenses have been issued since Monday, April 18, 2022.

Tuesday, April 19 is the day the FCC application fees became effective for amateur radio.

Amateur radio license filings are currently on hold until further notice and FCC did not estimate how long the system would be down.

Our goal is to get every one of the 67 counties in New England on the air so we hope you will encourage your friends to join in the fun! Even if you can join the fun for a couple of hours, we'd appreciate it! Will you be QRV? Let us know with a message to info@neqp.org

The New England QSO Party is 20 hours long overall, in two sections with a civilized break for sleep on Saturday night. It runs from 4 pm Saturday until 1 am Sunday, then 9 am Sunday until 8 pm Sunday. Operate on CW, SSB and/or digital modes on 80-40-20-15-10 meters. For each QSO you'll give your callsign, a signal report and your county/state. Top scorers can earn a plaque and everyone who sends in a log with 25 or more QSOs will get a certificate. The goal is to work stations anywhere in the world - and their goal is to work New England stations, so you'll be very popular!

Is your Email address on the FCC site up to date? § 97.23 Mailing and email addresses.

Each license grant must show the grantee's correct name, mailing address, and email address. The email address must be an address where the grantee can receive electronic correspondence. Revocation of the station license or suspension of the operator license may result when correspondence from the FCC is returned as undeliverable because the grantee failed to provide the correct email address.

[85 FR 85533, Dec. 29, 2020]

I recommend that you log on to the your FCC Registration at https://apps.fcc.gov/coresWeb/updateRegistrationPre.do to make sure that your email address is up to date. Also in the future should you change your home address or your email address be sure to remember to update it on the FCC site.

[Note that the FCC will be charging a \$35 fee for licence applications / renewals starting this month, but a change of address notification is still free. – ed.]

Making ZOOM available to Elmers


